Subject: Our Christmas Bird Count results

Good morning Debbie,

First off, this is my new personal email address which I'll be using going forward (and which won't be affected by any future Internet/TV/phone providers). Despite the cold, Dan, Ivan and I had an enjoyable day on the 2020 CBC. Unfortunately, Dave was unable to join us.

As is typical, we spent just over 2 hours in the Village; arriving at the Main Gate about 10:15 and leaving by the South Gate around 12:25PM. There are three main areas that we bird, the largest of course being the lake and its adjacent environs including the Clubhouse and Boat Club. The other two are the Racetrack (with the village's only grassland habitat) and the area around the school. Because of the snow there was a lot of bird activity along the roads - mostly Juncos and White-throated Sparrows - which we counted as we drove.

Tuxedo Lake itself is BY FAR the most important habitat within our entire Territory simply by virtue of the number and species diversity of birds we encounter there. Nowhere else - not Lake Sebago, not Sterling Lake, not any of the smaller lakes & ponds - do we find what we do on Tuxedo Lake. It is our "Ace in the hole" for increasing our species count but more importantly it gives us an accurate count of the birds - specifically waterfowl - in our Count Circle on the CBC day. One oddity was that we counted NO Mallards (the most common duck in North America) on your lake.

That being said, we did find a total of six species we found *nowhere else* but in Tuxedo Park; the doc shows them with asterisks but the are: Ring-necked Duck, Bufflehead, Ruddy Duck, Bald Eagle, Yellow-bellied Sapsucker, and Field Sparrow.

Some numbers:

42 bird species recorded, 26 in Tuxedo Park (61.9% of the total). The 6 species above represented 14.3% - a not insignificant amount.

1,131 individuals counted, 451 in Tuxedo Park (39.8% of the total). That is an HUGE number and as such, very important to the whole CBC effort.

I've attached a Word doc with our results of the day and the list specific to the birds we counted in Tuxedo Park.

As I've done so many times in the past, I write to request permission for a small group of volunteers from the Bergen County, NJ-based Fyke Nature Association to access the Village of Tuxedo Park during National Audubon Society's annual CHRISTMAS BIRD COUNT (CBC).
