Dear Mr. Sarcone:

As requested, an investigation has been conducted in relation to the above referenced matter. Specifically, our office was requested to confirm the primary address of the individuals/registered voters in question. The purpose of this investigation was to verify the current primary residence for each of the listed individuals.

In conducting this address verification assignment, our office reviewed open-source sites (social media, google and other search engines, etc.) and conducted inquiries with several different restricted data base platforms that are used by law enforcement and private investigators. In the case at hand, we conducted inquiries with IRBsearch, IDIcore, and TLOxp/Transunion and the Motor Vehicle Departments. Each of these database platforms provides real time identification and location of people, assets, and their interrelationships by collecting and focusing on information provided by thousands of different private and public sources.

The following investigation has been conducted to date:
