Below is a current update to all litigation matters which this office represents the Village of Tuxedo Park:

King-Duchin v. Village ZBA, Ledwith, et al.

(Orange County Supreme, Index No. EF005221/2020)

Adjournment was granted and return date was adjourned to December 1, 2020.

Article 78/ TRO request filed by King-Duchins' appeal from the determination of Building Inspector concerning the seasonal use of residence at 47 Clubhouse Road. Adjournment to answer/move was granted until 11/6/20; return date is 11/13/20. However, the Court since adjourned this to December 1, 2020. However, Petitioners have agreed to vacate the residence from November 21st through at least the December 1, 2020 return date as all parties had consented if the TRO is denied, Plaintiffs would have up to 11/20/20 to vacate premises. Our office represents John Ledwith and Attorney Alyse Terhune represents the Village BZA.

Miller v. Village

(Orange County Supreme, Index No. 000704-2020)

Ongoing litigation being defended by insurance carrier assigned attorney, Michael Cook (Cook, Netter, Kurtz and Murphy). Litigation brought by Millers against the Village and a neighbor Ms. Hess due to drainage damages to Miller's property (driveway) as a result of neighboring driveway being in disrepair and poor design. Answer to Cross Claim filed on behalf of Village on 7/8/20. This litigation is in discovery phase and further details would need to come from Mr. Cook.

Madden v. Village

(Article 78 concerning FOIL requests and Appeal, Docket No. 2018-08105.)

This litigation has been fully submitted to the Appellate Division since 2019. We are awaiting a decision from the Appellate Division. No oral argument was held as both parties agreed to submit on the briefs.

<u>PERB:</u> Matter of Part-Time Police Officer Petition for Certification (Teamsters Local 445) (PERB Case No. C-6597)

A conference call was held with ALJ Sergeant on October 29, 2020. ALJ Sergeant denied the Union's request and suggested that an appropriate bargaining unit would consist of full and part-time officers. ALJ Sergeant advised the Teamsters Union to file a new Petition to seek decertification of the Tuxedo Park PBA Union and establish a new bargaining unit consisting of full and part-time police officers. This matter was placed on a 30 day hold for Attorney Kern to withdraw and/or file a new Petition. The previously scheduled December conference and January 2021 hearing have been adjourned without a new date.

Taback v. Village of Tuxedo Park

(Orange County Sup., Index EF004179/2020)

A Notice of Appeal was filed on October 28, 2020. The appeal must be perfected before April 28, 2021 (6 months from the filing of the Appeal).

Yacknowitz v. Taback & Village

(1983 Civil Action brought for excessive force/false arrest - S.D.N.Y. Docket No. 19 cv-02774) *(Insurance carrier handling)

Settled. Order of Discontinuance was filed 9-9-20; General Release signed 9-3-20.
