I am aware of the racetrack nature preserve as I donated three bluebird boxes there and the village helped install them so super excited to see that the bluebird boxes are successful there.

I also frequently enjoy the trails.

Would be happy to collaborate with either Sue on the trails or Chris on the racetrack nature preserve. I can certainly reach out to them if and when I manage to have the time.

I was able to pick up two very large garbage bags full from the front gate all the way to the Tuxedo Club boathouse and back. For the area I covered it was definitely worthy and worth the time.

The thing with the letter clean up is that it may be a seasonal adjustment we should do and that is to possibly do it in the fall or rather just after Labor Day because that is when the park will have the most garbage from being frequented by summer visitors and guests as well as full occupancy.

I spoke briefly with Chris Hansen and we agreed we might do a second one after summer. And with that we want to possibly focus volunteers on the higher traffic areas such as Tuxedo Road East Lake Road and West Lake Road.

Beyond that I'm all ears as to what we can do another Earth Day matters as well, though I will say I'm finding my volunteer time to be quite limited kind of one-off scenarios that I can contribute such as this quick litter cleanup.

I have yet to send a thank you note out to the volunteers that were part of it there were seven or so families that participated so I will be sending them a note.

Some families participated with children and if nothing else it's a great lesson for them to remember as well.

I can also say it was good to see that some areas of the park are relatively clean but when you get into it there's always litter to be found. If some areas of the park were clean before our pick up they're super pristine right now at least by the sides on the roads. :-)
